The Company is deemed the commercial enterprise Divoká voda, s.r.o. with Headquarters in Nám. SNP 14, 811 06 Bratislava, Company ID: 35 828 170, incorporated in the Companies Register of the District Court Bratislava I, Section: Sro, File No.: 25725/B.

I am aware that during my participation on any sport activity organized in the Divoká voda site some unexpected events may occur including:

- extreme weather, low water temperature, and sudden weather changes;
- potential unexpected injury or material damage;
- psychic shock caused by swimming in white water.

I hereby declare that:

- I was duly instructed in safety rules in terms of the operating rules and I am aware of potential risks resulting from the demands of the sport activity;
- I am not under the influence of alcohol or drugs or other intoxicants;
- I will inform instructors of my health problems that are known to me and that could cause health problems during my participation on sport activities;
- I will inform instructors of any accident occurred during a sport activity;
- I am good at swimming (applicable to water activities only);
- in no case whatsoever shall I ask the Company for compensation of any injury or health or property damage, since I perform sport activities at my own risk;
- I agree with Company's use of photos, videos, and audio records made at the consumption of a purchased sport activity for the Company's commercial purposes;
- should my action/inaction cause damages to the Company's property, I shall pay for it in accordance with retail prices;
- I am aware of the penalty of EUR 100 for quadricycle overturning;
- should I fail to follow instructor's orders at leaving the bank and arriving to the bank and suck in (foul) the personal watercraft motor propeller, I shall pay EUR 50 for professional cleaning of the personal watercraft and putting it back into operation.

I hereby confirm by my signature that I have read and I understand this declaration – waiver and that I participate on the Company's sport event at my own risk.

SURFING

WAIVER REGARDING PERFORMANCE OF ACTIVITIES AT ONE'S OWN RISK AND RESPONSIBILITY

I, the undersigned, hereby honestly declare that I was notified of the fact that the obstacle – artificial wave erected in the water channel located in operation premises of the Divoká voda Company consisting of the WSAC site in the cadastral territory of the municipality of Čunovo to be used for performing water activities /surfing/ is not certified and that its design documentation is under construction.

- I hereby declare that I was notified of the risks and that any and all consequences, a potential sudden failure or defect of the obstacle - artificial wave could result in during the performance of water activities /surfing/ thereon, were explained to me.
- Regardless of the explanation and notification of the risks I hereby declare that I am interested in performing water activities on the obstacle - artificial wave at my own risk and responsibility and that I shall not file a claim with the Company to any compensation for any property or health damage occurred.
- I, being of sound mind, confirm this by my own signature as my free will and deed.
